

# Public School Choice

Under the *No Child Left Behind* Act, the District must provide educational choices for students who attend a Title I school identified as “in need of improvement” for not making adequate yearly progress (AYP) for two consecutive years. The list to the right contains Title I schools that **MUST** offer public school choice for the 2009 - 2010 school year. Parents who are interested in transferring their child to a public choice school must complete a registration form at this time.

A school is determined to have made adequate yearly progress (AYP) if it receives a “yes” in academic achievement targets established by the Florida Department of Education. If a school receives just **one** “no” then it does not make AYP. Many of the best performing schools in Brevard County do not make AYP. Parents who have children attending a Title I school that has not made AYP for two or more consecutive years have four (4) choice options - remain at the current school, attend a designated public choice school with transportation, choose from an array of choice programs available in the district, or keep their children at the current school to participate in Supplemental Education Services (SES) provided by a State approved private provider.

It is important to note that you do not have to transfer your children to another school. Your Title I school offers special educational programs to support student learning. These programs may include looping (keeping the same teacher for more than one year), special pull-out programs, computer assisted instruction, small classroom settings, unique curriculum, etc. You are encouraged to call or contact your child’s school to learn about the excellent programs available.

## Transferring to a Public Choice School with Transportation is Offered to:

Any student who was enrolled and registered during the 2008 - 2009 school year at a Title I School that is in “School Improvement Status.”

Any Kindergartner or new student to Brevard County who resides in the assigned boundary area of a Title I school that is in “School Improvement Status.”
